#### **Key Responsibilities**

- c. Collaborate with the Director General and other Directors to align technology initiatives with service-oriented goals of the Authority
- d. Ensure the availability, security, and performance of networks, servers, and other IT systems
- e. Support related procurements and contract management.
- f. Overseas the IT helpdesk, ensuring timely and effective resolution of user issues
- g. Develop and implement IT training programs to enhance the technology literacy of the staff.

#### **Qualifications and Experience**

a) A Bachelor's Degree recognized by the University Grants Commission (UGC) of Sri Lanka in Information Technology, Computer Science, Computer Engineering, Data Scenes, Data Processing Management or any other Degree relevant to the post, recognized by the University Grants Commission (UGC) of Sri Lanka <u>and</u> a Postgraduate Degree (Master's) in Information Technology, Computer Science, Computer Engineering, Data Science, Data Processing Management or any other field relevant to the post or Associate Membership of a recognized professional Chartered institution in Information Technology or related field <u>with</u> at least six (06) years of managerial level experience in corporation, statutory board/Institution or reputed private institution

Age: Age should be not less than 30 years and not more than 35 years

#### REMUNERATION AND BENEFITS

- a) Fixed-term contract initially for a period of these (03) years with entitlement to Employees' Provident Fund (EPF) and Employees Trust Fund (ETF)
- b) An attractive remuneration package along with other benefits, enjoyed by the fixed term employees of the Authority.

#### OTHER REQUIREMENTS

- a) Should be a citizen of Sri Lanka.
- b) Should be physically and mentally fit to discharge the duties of the post.
- c) Should be of excellent moral character

- d) Should have an excellent command of the English language as interactions with international agencies and other institutions overseas is a job requirement for professional grades.

**Method of Selection:** Suitable candidates will be selected based on one or more interviews. Appointments will be made purely in order of merit.

The secondment period is initially for one (01) year, and the renewals will be subject to the job holder's performance and other organizational requirements.
